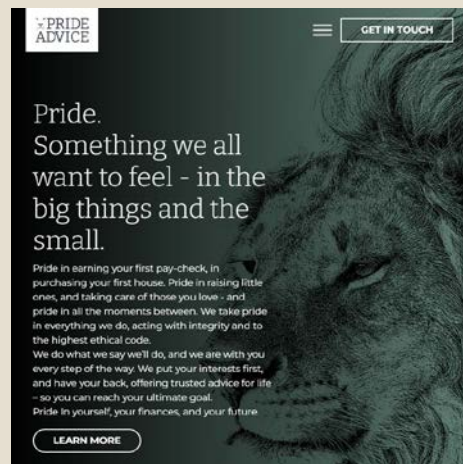


Our new website is launched!

Changes to Centrelink payments

Last month, the Federal Government confirmed an increase in Centrelink payment rates to be effective from 20 March, 2024. Single recipients of the Age Pension, Disability Support Pension and Carer Payments have had a total increase of \$19.60 a fortnight, while couples have had a combined total increase of \$29.40 a fortnight.
